In its policies, procedures, practices and activities, the school will adhere to the following principles of best practice in child protection and welfare:

The school will:

- ◆ recognise that the protection and welfare of children is of paramount importance, regardless of all other considerations;
- ◆ fully comply with its statutory obligations under the Children First Act 2015 and other relevant legislation relating to the protection and welfare of children;
- ◆ fully co-operate with the relevant statutory authorities in relation to child protection and welfare matters;
- ◆ adopt safe practices to minimise the possibility of harm or accidents happening to children and protect workers from the necessity to take unnecessary risks that may leave themselves open to accusations of abuse or neglect;
- ◆ develop a practice of openness with parents and encourage parental involvement in the education of their children; and
- ◆ fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

- ◆ Risk of harm due to inadequate supervision of children while attending out of school activities

- ◆ Risk of harm due to inappropriate relationship/communications between child and another child or adult
